



ALAMEDA MARINA

This application is for a water berth at Alameda Marina. The application must be filled out completely and all requested documents supplied. **All information is subject to verification by the marina. False or missing information may cause us to deny the application.**

All applicants for a new berth must supply proof of ownership. Current California DMV registration or current USCG documentation is preferred. Applicants purchasing boats currently in Alameda Marina may supply proof of ownership in the form of a valid vessel title in the name of the current tenant and bill of sale or Vessel Transfer form in lieu of current registration. Transfer of slips is not guaranteed.

All applicants must supply proof of \$250,000.00 per incident liability insurance.

Applicant must be able to receive bills at a physical address. We do not send bills to P.O. boxes and we do not rent space to persons without a physical home address. All tenants must supply a valid email address, and that address must be kept current.

Alameda Marina acceptance criteria:

- We are not currently accepting wooden boats, and are not accepting power boats less than 24 feet in length.
- Boat must be seaworthy, clean, with no tarps or makeshift coverings; All openings on decks or cabins must have designed hardware covers. There can be no debris on the boat; only necessary sailing equipment is allowed.
- Boats 20' or longer must have operating propulsion machinery; Boats greater than 28' must have working internal auxiliary propulsion machinery. We do not allow boats to be towed into the marina.
- All boats with a head must have a Type I, II, or III marine sanitation device installed.
- All boats MUST comply with USCG minimum equipment and signage regulations.
- All rigging must be intact, masts stepped, and dinghy stored on board.
- We do not accept boats that have significant visible collision or other damage.

The harbormaster may require a survey of the vessel, and may do a background check or credit check. No credit check will be done without the applicant's permission. The accompanying application must be filled in completely.

Email or fax copies of proof of ownership can be sent with this application, but originals MUST be presented at time of arrival of the boat.

We reserve the right to deny the application at any point in the process. We are not obliged to share the reasons for denying any application.

Alameda Mooring and Anchorage Rules:

Vessels may berth in the marina only with the permission of the Harbormaster. The Harbormaster has the right to refuse the application for use of the marina and/or cancel a berthing permit at any time.

Vessels entering or mooring in the marina without permission will be considered trespassing and will be subject to civil and criminal penalties. Vessels in distress must contact the harbormaster's office immediately upon arrival. There is no temporary docking available at Alameda Marina. Customers of Marina businesses that are not marina tenants are not allowed to park boats in the marina while they do business on site.

All vessels mooring in the marina without a marina wharfage contract are subject to the California Boater's Lien Law. Documented vessels will be subject to arrest by Federal Marshall. Unauthorized boats will be charged the transient rate of \$20.00 per day, payable in cash. Failure to make payment will result in impound and application for permission to perform a lien sale with the California State DMV. Acceptance of payment does not represent permission to moor.

We expect all boaters to use Alameda Marina facilities in a safe and responsible manner. We encourage all boaters to wear life-jackets, keep ground tackle available on their vessels, and maintain a lookout when operating. We encourage all boaters to take a boating safety class. Any vessel entering without an approved, valid application or with an expired application, or failing to execute a contract within 24 hours of entry will be considered trespassing and will be subject to civil and criminal penalties including but not limited to impound of the vessel, lien sale, and prosecution by local authorities.
